Minutes for the Town of Twin Bridges Regular Council Meeting

Tuesday, April 8th, 2025, 7:00 p.m.

The meeting was called to order at 7:04 p.m. In attendance were Interim Mayor, Matt Greemore, and Council members Councilor Scott Holbrook, Councilor Nolan Frandsen, Councilor Jordan High and Councilor JB Klyap was in attendance.

The Pledge of Allegiance was said.

There was a comment on public Non-Agenda items.

Building permit for senator lane that is close to expiration was discussed and recommended action is to renew the permit.

New Business:

Erosion on 2nd Ave there are stakes in the ground to analyze the amount of erosion. We are looking into grants to assist in repairing the damage and removing the two islands that are causing the issue. Great west is looking into grants to find money to complete the task. Councilor JB made a motion to have Great west start the process Councilor Nolan seconded all in favor motion carried.

Ruby Valley Medical Sign the sign location will need to be moved back from the sidewalk, and this would increase the visibility of traffic and walking path of the sidewalk. The council feels that it needs to be 5 ft from the sidewalk, with neighbor property permission. Councilor Greemore made a motion to a variation in ordinance to 2ft 6in and try to obtain 5 feet from sidewalk. all in favor.

DNRC Arbor Day/Tree board discussion on grant and what needs to be done we also received 24 seedlings to help teach people about trees. Locations on where the trees will be planted and the recommended trees. There will be training on Thursday 10 April.

Senior center building permit they will be extending the building to make a safer area for the personnel to cook in. Councilor Nolan made a motion seconded by Councilor JB to approve all in favor motion carried.

Kathy Schaffer Moeykens Alley question of where the railroad is compared to city alleyway. Railroad is 50 ft in both directions from center of the railroad track. There was a gas tax property/road/easement paperwork that will be looked at to verify.

Old Business:

Sheriff MOU will be delivered by the next town hall meeting.

Sewer bill will be adjusted to a flat rate with an 8 percent increase. Councilor Scott first the motion and Councilor Jordan second the motion all favor motion carried.

Water meters are in route from Neptune and they will be installed shortly after receipt removing master meter. Letter will be sent from Lawyer to tell them that they will refund us on the equipment that does not work.

MOU has not made forward motion. McCallie school is concerned about the timeline. The town does not have any issues with the school and is happy to

accommodate where we can. The MOU has not been seen by any of the people involved.

Subdivision committee to review standards of the zoning.

Great west received bids the lowest bid was from 40/50. They will need some oversight, and Great West is willing to overview. Need a sight done prior to release of funding. Great west will need to have this done ASAP to release the thousands. GW recommends awarding the bid to 40/50. Councilor Scott made motion to approve the 40/50 bid seconded by Councilor Jordan all in favor motion carried.

Visit with dan for funding bond council title and support for the project.

Reports:

The Sheriff's report was presented.

The Madison County Planning Board Report was presented for the Growth Policy, floodplains, and subdivision regulations.

The Library Directors report discussed.

The Fire Department had minimal calls one new employee and one old employee was removed. Fire department has renewed their CPR cards.

Maintenance Supervisor Rick discussed the high school banners of senior students have expressed a desire to be put up on the poles through main street. Equipment inspections on all implements. Conducted Safety inspections IAW OSHA. The scissor lift has tire quotes. Motion made by Councilor Jordan to purchase the best priced tires after getting last quote from Butte. Second by Councilor Scott all favor motion carried.

The attorney gave her an update.

Interim Mayor, Matt Greemore Continuing have been fixing problems as we find them. Budget will need to be reviewed as a working party.

The Town Clerk discussed previous minutes that need to be signed, past due bills, checks to be issued. Accounting issues are now being worked on to fix issues that have been found. Checks and paperwork have been signed. Motion to approve consent agenda by Councilor Jordan, seconded by Councilor JB all in favor motion carried. Water shut off notices will be sent out and late fees will be reinstated.

Consent agenda event ordnance and planning review combined working meeting. Reaching out to the community for members to participate. Motin by Councilor Scott seconded by Councilor JB.

The next regular meeting is scheduled for May 13, 2025.

Councilor Nolan moved to adjourn Councilor Scott Seconded. All voted in favor.
